- 6 By becoming a member of Deltaserat you agree to be bound by these terms and conditions and you
- 7 agree with our privacy policy¹. If you do not accept these terms and conditions and our privacy
- 8 policy you cannot become a member of Deltaserat.
- 9 We hold the right to change the terms and conditions at any given time which can then be found on
- 10 our website. Please revisit the terms and conditions periodically to stay up-to-date with any changes.

13 <u>I. Payment of membership contribution</u>

- 14 *I.I* Debit authorization
- 15 As a member of Deltaserat you agree with signing two direct debit authorizations. Authorization is
- 16 given by checking the payment approval box when signing up on the website and by filling in and
- 17 signing the physical SEPA mandate form that the board will provide to you in person. By signing both
- 18 authorizations you allow for the agreed upon amount to be debited from your bank account
- 19 periodically by Deltaserat until a formal termination of the membership has been requested or when
- 20 the membership has been terminated by the board.

22 I.2 – Exemption of payment

Exemption of payment is only available in case a member was not able to train due to force majeure, in the case of a scholarship or when a member has cancelled their membership within a month after signing up as a member. Any force majeure has to be proven and will be judged by the board.

- 27 I.3 Payment options
- 28 1.3a Payment per semester By choosing for the 'payment per semester' option you agree to sign up for a 29 30 membership at Deltaserat for the entire semester in which the date of signup falls. 31 You allow Deltaserat to debit €75.00 from your bank account to cover the cost of 32 the membership over this semester. The first semester runs from September until 33 January and the second semester runs from February until June. The membership 34 contribution of the first semester will be debited between November 25 and 35 November 30 and the membership contribution of the second semester will be 36 debited between April 25 and April 30. Within each month the membership 37 contributions are debited all members will be notified when the direct debit will 38 exactly take place. When signing up during July or August your membership start in 39 September and will be treated equally to a signup during the first semester. Signing 40 up after the debit date of the semester you are required to manually transfer the 41 agreed upon amount to Deltaserat. All memberships will automatically be continued 42 after every semester until a formal termination of the membership has been 43 requested or when the membership has been terminated by the board. 44

- 45 1.3b Monthly payment 46 By choosing for the 'monthly payment' option you agree to sign up for a 47 membership at Deltaserat for the entire month in which the date of signup falls. You 48 allow Deltaserat to debit €20.00 from your bank account to cover the cost of the 49 membership over this month. The membership contribution will be debited on the 50 final day of each month. All members will be notified when the membership 51 contributions are debited. When signing up during July or August your membership 52 start in September and will be treated equally to a signup in September. Your 53 membership will automatically be continued after every month until a formal 54 termination of the membership has been requested or when the membership has 55 been terminated by the board.
- 57 1.4 – Altering the payment option

58 Switching from 'payment per semester' to 'monthly payment' or vice versa can only be done at the 59 end of the membership period the member signed up for agreed or agreed to switch to previously 60 (i.e. at the end of a month or semester). The amount of membership contribution to pay when

- 61 witching from 'monthly payment' to 'payment per semester' will be calculated based on the following 62 formula: €75.00 - €15.00 × n, with 'n' being the number of months within a semester that the
- 63 member requesting the switch has already been a member for. Requesting an alteration of payment
- 64 method can only be done within a period of thirty days before the alteration is to take place.

- Alteration of a payment option can only be performed once per academic year. 66

67 2. Rules

KICKBOXING

- 68 As a member of Deltaserat you agree to behave respectfully towards the trainers and your peers.
- 69 Members of other associations that are not associated with ACLO are not allowed to train at
- 70 Deltaserat unless they have formally requested to be a member and have been accepted by the
- 71 board. Deltaserat has the full right to dismiss members and deny entrance to the dojo when the
- 72 concerning member has been deemed of unruly behavior and has been warned twice. In extreme
- 73 cases Deltaserat has the right to dismiss a member without warning. 74

75 3. Safety

- 76 As a member of Deltaserat you agree to take into account your partner's size and skill level. When
- 77 training together the more advanced and/or bigger training partner will adjust to the level of the 78 smaller and/or less experienced member. Members will <u>always</u> follow the instructions of the trainer
- 79 and/or board.
- 80 As a member of Deltaserat you agree to wear appropriate attire. Members are not allowed to wear
- 81 jewellery during training. In kickboxing men are required to use either 14oz or 16oz gloves and
- 82 women are required to use 12oz or 14oz gloves. All members are obliged to wear protective gear
- 83 where necessary.

85 4. Membership cancellation

- 86 A membership at Deltaserat can only be cancelled when an email is sent to <u>bestuur@deltaserat.com</u>.
- 87 Any other forms of cancellation (such as replying to an email, sending an email to a different email
- 88 address or verbal cancellation) will not be accepted. The board also holds the right to terminate
- 89 memberships at any given time when they establish a good reason to do so. Any member who's
- 90 membership is terminated by the board will be notified.

91 **<u>5. Accountability of injury and loss of goods</u>**

- 92 Deltaserat cannot be held accountable for any physical harm caused during training or inside the
- 93 dojo. Deltaserat cannot be held accountable for missing goods.
