4 **0. Introduction**

5 Please read the terms and conditions very carefully before becoming a member of
6 Deltaserat. By becoming a member of Deltaserat you agree to be bound by these terms and
7 conditions, and you agree with our privacy policy¹. If you do not accept these terms and
8 conditions and our privacy policy, you cannot become a member of Deltaserat. We hold
9 the right to change the terms and conditions at any given time which can then be found on our
10 website. You will be notified of any changes to the terms and conditions by email. Please
11 revisit the terms and conditions periodically to stay up to date. Members can write a formal
12 complaint to bestuur@deltaserat.com in case of disagreement with the updated terms and
13 conditions.

15 **1. Payment of membership contribution**

16 *1.1 - Debit authorization*

17 As a member of Deltaserat you agree with signing two direct debit authorizations.
18 Authorization is given by checking the payment approval box when signing up on the website
19 and by filling in and signing the physical SEPA mandate form that the board will provide to you
20 in person. By signing both authorizations you allow for the agreed upon amount to be
21 debited from your bank account periodically by Deltaserat until a formal termination of the
22 membership has been requested or when the membership has been terminated by the
23 board.

25 *1.2 - Exemption of payment*

26 Exemption of payment is only available when: the member was not able to train due to force
27 majeure; a scholarship applies to the member; the member has cancelled their membership
28 within a month after signing up as a member. Any force majeure has to be proven and will be
29 judged by the board.

1.3 - Payment options

1.3a Payment per semester

By choosing for the 'payment per semester' option you agree to sign up for a membership at Deltaserat for the entire semester in which the date of signup falls. You allow Deltaserat to debit €75.00 from your bank account to cover the cost of the membership over this semester. The first semester runs from September until January and the second semester runs from February until June. The membership contribution of the first semester will be debited between November 25 and November 30 and the membership contribution of the second semester will be debited between April 25 and April 30. Within each month the membership contributions are debited all members will be notified when the direct debit will exactly take place. When signing up during July or August your membership start in September and will be treated equally to a signup during the first semester. Signing up after the debit date of the semester you are required to manually transfer the agreed upon amount to Deltaserat. Failure to manually transfer the agreed upon amount will result in the treasurer withdrawing the regular semester payment in full. Memberships will automatically be continued after every semester until a formal termination of the membership has been requested per email to the board or when the membership has been terminated by the board.

1.3b Monthly payment

By choosing for the 'monthly payment' option you agree to sign up for a membership at Deltaserat for the entire month in which the date of signup falls. You allow Deltaserat to debit €20.00 from your bank account to cover the cost of the membership over this month. The membership contribution will be debited on the final day of each month. All members will be notified when the membership contributions are debited. When signing up during July or August your membership start in September and will be treated equally to a signup in September. Your membership will automatically be continued after every month until a formal termination of the membership has been requested or when the membership has been terminated by the board.

1.4 - Altering the payment option

Switching from 'payment per semester' to 'monthly payment' or vice versa can only be done at the end of the membership period the member signed up for agreed or agreed to switch to previously (i.e. at the end of a month or semester). The amount of membership contribution to pay when switching from 'monthly payment' to 'payment per semester' will be calculated based on the following formula: $€75.00 - €15.00 \times n$, with 'n' being the number of months within a semester that the member requesting the switch has already been a member for. Requesting an alteration of payment method can only be done within a period of thirty days before the alteration is to take place. Alteration of a payment option can only be performed once per academic year.

75 **2. Rules**

76 As a member of Deltaserat you agree to behave respectfully towards the trainers and your
77 peers. Members of other associations that are not associated with ACLO are not allowed to
78 train at Deltaserat unless they have formally requested to be a member and have been accepted
79 by the board. Deltaserat has the full right to dismiss members and deny entrance to the dojo
80 when the concerning member has been deemed of unruly behavior and has been warned
81 twice. In extreme cases Deltaserat has the right to dismiss a member without warning.

83 **3. Safety**

84 As a member of Deltaserat you agree to take into account your partner's size and skill level.
85 When training together the more advanced and/or bigger training partner will adjust to the
86 level of the smaller and/or less experienced member. Members will always follow the
87 instructions of the trainer and/or board. As a member of Deltaserat you agree to wear
88 appropriate attire. Members are not allowed to wear jewelry during training. In kickboxing
89 men are required to use either 14oz or 16oz gloves and women are required to use 12oz or
90 14oz gloves. All members are obliged to wear protective gear where necessary.

92 **4. Membership cancellation**

93 A membership at Deltaserat can only be cancelled by email sent to bestuur@deltaserat.com. Any
94 other forms of cancellation (such as replying to an email, sending an email to a different email
95 address or verbal cancellation) are invalid. Cancellation of membership takes effect the
96 month following the request for cancellation. For instance, sending the request within
97 October will result in termination of membership November 1.

98 The board holds the right to terminate memberships at any given time when they establish a
99 good reason to do so. Any member whose membership is terminated by the board will be
100 notified.

102 **5. Accountability of injury and loss of goods**

103 Deltaserat cannot be held accountable for any physical harm caused during training or inside
104 the dojo. Deltaserat cannot be held accountable for missing goods.
